



## Magnolia Meadow Farms Photography Policy

Updated February 2024

### **WEEKEND BUSINESS HOURS:**

**We welcome amateur visitors and/or professional photographers to visit our farm to take photos.**

- You may visit during our weekend business hours on Saturdays and Sundays. No one is allowed on Magnolia Meadow Farms property after business hours unless it is by reservation.
- Everyone entering the Magnolia Meadow Farms property must purchase an admission ticket, including the photographer.
- You may use a camera or cell phone.
- You may take photos on any public part of the farm.

### **Rules:**

- Do NOT enter any of the areas marked No Access, Do Not Enter, or areas with farm equipment.
- Do NOT disturb flowers, vegetation, crops, displays, etc. including sunflowers, cut flowers, and pumpkins. Nothing may be picked and used during your session, unless you are paying for it.
- Please be courteous and polite to all visitors and our staff. No public area may be closed or blocked off.
- Absolutely NO PETS are permitted on the farm.
- Any session deemed disruptive or inappropriate will be directed to leave without refund.

### **PRIVATE PROFESSIONAL PHOTOGRAPHER SESSIONS:**

We offer exclusive evening sessions for those who wish to use Magnolia Meadow Farms as a setting for any portrait/commercial photography, even if the photographer is not compensated, financially or otherwise. We require a reservation to be made through our ticketing website:

### **Photography Session Times:**

- During our 2024 season, we will be offering sessions on Thursday evenings from 5:00pm to 7:00pm (2 hours). The cost is \$100 per session.
- You may have multiple clients during the 2 hour window.

### **Check In:**

- Please park in our main parking lot and check in at the Ticket Building. We will make sure that we have your reservation on our schedule.

### **Locations:**

- Sessions are to take place in our sunflower, cut flower, or pumpkin fields. These are accessible by a short walk across our activity area.
- The activities will NOT be open during these sessions, and you are not permitted to use them.
- You may NOT enter any areas marked No Access, Do Not Enter, or areas with working farm equipment.

**Rules:**

- You must park in the parking lot. Driving your vehicle to our fields is prohibited.
- All props must be carried to your photoshoot location. Props or equipment that cannot be carried easily should not be used.
- Do not disturb flowers, vegetation, crops, displays, etc. including sunflowers, cut flowers, and pumpkins. Nothing may be picked and used during your session.
- All photos should be “family friendly” in nature.
- Please supervise all children at all times
- Absolutely NO PETS are permitted on the farm.
- All props must be removed upon departure.
- We require that all trash be removed from the photo site.
- All photographers and clients must leave promptly by 7:00pm.
- Any session deemed disruptive or inappropriate will be directed to leave without refund.

**Crops:**

- Sunflowers, cut flowers, and pumpkins are agricultural crops and therefore subject to weather, growing conditions, and ripening variables. We cannot guarantee what they will look like on a particular date, so please prepare to be flexible with your visit.

**Rain Policy:**

- If poor weather or unsafe conditions are expected on the day of your reservation, a farm manager will contact you by the phone number or email listed on your reservation. Rain dates cannot be given at the time of booking, but rescheduling is possible if open time slots are available. If rescheduling isn't an option, a full refund will be issued.
- We are NOT able to refund your pass once you have ENTERED the farm. Passes that are unused for any other reason are non-refundable.
